

### Bulletin

To the local clubs—If your club is preparing an article for the BFCA bulletin, please remember that it should be only one page in length. Also, please send the article to me in a written form, not just random information. This would be very helpful for me.



### Obedience/Rally

There are new rules that have taken effect as of December 1, 2015. Here is a summary along with the location of where you can find them in the new AKC Regulations book of Obedience.

If a Novice dog was entered in the Novice class mistakenly and it has no obedience titles, that dog may be transferred to the Beginner Novice Class. Clubs may offer Highest Scoring Dog and High Combined in the Preferred Classes. All dogs that had Pre- class legs or titles will automatically be transferred into Preferred class certification

Ch. 1: Exhibitors may leave the ring (pg. 29.) If the handler leaves the ring, the Judge will mark the score sheet as HLR and carry a NQ to the score box. Ten minutes are added into the 1<sup>st</sup> hour of judging for all classes that have walk-thrus (pg.21.) Listed start time is the time for the walk thru with judging to follow. Trials/classes starting at or after noon will now list the start time instead of the words "to follow." If the published ring and Judge are available prior to the start time listed and all the exhibitors have checked in and agree, the Judge may now start the class earlier.

CH. 3: Novice Group Exercises: Judges must decide prior to the Judging and post whether the Group exercises will be done after a certain amount of dogs or at the end of the judging of the individuals (pg.40.) All exhibitors are now required to tell the steward as they leave the ring whether or not they will return for the Group exercises. They cannot change their mind once they have told the steward. NQ for not returning. All handlers have the option of returning unless excused or released by the judge. The leash remains attached to the dog's collar (no slip leads) and resting along the side of the dog with the armband #.

CH. 5: Utility Scent Discrimination (pg. 52, 53) 10 articles to be used- may use Leather, Metal or wood now to make up the 5+5 articles. I bet there will be a lot that switch to Leather and wood for this (I know I would have been able to get into the Utility ring faster if I had this option over metal.) Handler may watch the articles being put out or not. You now cannot take an article until the Judge asks if you are ready and then tells you to take an article. Scoring has begun at that point. You may talk to your dog while scenting but not touch your dog to pet it as scoring has begun. Your dog must remain in the heel position and stay while you get the article. Repeats for 2<sup>nd</sup> article. Directed Retrieve (pg. 55) NQ if the handler does not give a verbal command to retrieve the glove. Substantial to NQ if the handler does not give the direction and the verbal simultaneously or immediately following the direction to retrieve the glove. Moving Stand: (pg. 55) The exam now will be the judge gently touching the dog in a single motion beginning at the side of the dogs neck proceeding along the body and ending at the croup. Preferred titling- now called Alternative Titling Classes: Novice- for dogs that have not won the CDX or PCDX, walkthrough of up to 10 minutes allowed. Open: for dogs that have won the CD or PCD title. Open B orders to be posted. Jump Heights are at  $\frac{1}{2}$  the height level of regular Open ring work and orders to be used will be posted prior to the start of class. No Groups exercises. Utility: for dogs that have won the CDX or PCDX. UB orders listed prior to show, all exercises are the same as Utility but jump heights are  $\frac{1}{2}$  the height. Jump height must be listed on application form.

PUDX: Qualifying scores in both Preferred Open & Preferred Utility 10 separate trials. POC: Preferred Obedience Champion: 750 points. Must have PCDX & PUTD to earn points. Qualifying scores in both Preferred Open and Preferred Utility at 20 separate shows.

Graduate Novice: (pg.84-86): HF and Fig. 8 now both off leash. Dumbbell Recall over the High Jump. Graduate Open (pgs. 88-90) Order of the exercises shall now be: Signal exercise, scent discrimination, Go out, Directed Jumping, Moving stand, Directed Retrieve.

There is more information to read but this is the jist of the changes effecting us for the year 2016.
