Committee Reports-Obedience Reports, Linda Ferrullo

New changes are coming April 1st to the Rally classes of the AKC. Judging schedule will change from 22 dogs per hour to 20 dogs per hour. You need to know this when planning your arrival for the show ring. You also must keep a close eye on the entry board to make sure of absent exhibitors. Many Judges are not handing out course maps and are just posting the course somewhere near the ring for you to view so make sure you are current on or able to look up how to do the signs prior to entering your ring. The Judge cannot tell you how to do the exercise at a show during the walk thru.

Minor to substantial points have changed from 1-3 points to 1-10 points. A substantial deduction of 6-10 points has been added for Luring/Pleading with the dog. It used to be allowed with no penalty. Honor has been replaced with sit/stay in the Excellent class and if the dog breaks there is no retry, it is considered a -10 points for that. Also in Excellent, the AKC has placed the deduction to be imposed for those handlers that clap or pat their legs in the Excellent class, which always was not allowed, to be 1-10 points per occurrence. A Non-Qualifying score also now has been added to the scoring for any exhibitor that approaches a sign but does not begin the exercise on the sign- it will be considered "station not attempted" by handler" so be careful to read those signs correctly as you approach them. Also, I want to remind those that play in Rally that the rules state the handler must be directly in front of signs for change of direction. It is up to the Judge to properly place the sign in the correct position but the handler is required to come up to that sign and be close to it before they do the exercise or they can be considered "Not attempted" and NQ for not being near enough to that sign. That has always been in place but some of the Judges are finally realizing that they have not been scoring this before and will be now after they have gone to a couple of seminars it has sunk in. Exercises using cones may require entries with the sign to the exhibitors Left and all other signs will be placed on the right of the handlers' path. Except for exercises requiring entry with the sign on the left, exercises are performed near the signs with either being directly in front (for change of direction) or in front and to the left of the signs.

The AKC also has started to change the numbers for the signs. They have added to the Novice level 5 new signs numbered 32 - 36 and these signs also may be used at any of the other levels. No change to Novice signs 1-31.

32- Figure 8 w/no distractions- 2 posts used for this, team enters with the posts on either left or right and will perform a complete figure 8 around the posts, must enter center 3 times to be correct.

33- Halt, Left turn, forward- Team halts, dog sits, handler turns left and dog must follow immediately with handler as they move forward without any hesitation. Change of direction so sign must be done directly in front of, 34- Halt, right turn, forward- Handler halts, dog sits. Handler turns right and dog moves with handler as they go forward. Change of direction, sign is directly in front of you as you perform this, 35- Call Front- Return to heel. - while heeling the handler stops forward motion and calls the dog to the front position (dog must not sit in heel prior to being called to front) and the handler may take several steps backward as the dog and return to heel position and pause. Dog must remain sitting while handler walks around it. This is a change in direction sign but it can be in front or to the right. 36- Halt-slow forward from sit-the team halts and the dog sits; the team then moves forward in a slow pace until they reach the sign Normal.

Advanced signs have been renumbered 101-118 with 4 new signs added. 115-Halt-Stand - dog sits at heel position, handler stands dog, dog may be posed, handler pauses before moving forward, 116- Halt-Pivot right-forward- Handler halts and dog sits, handler pivots right with dog and continues to move forward, 117- Halt-pivot left- forward- same as 116 sign but moving to the left instead, 118- Halt- leave dog- 2 steps- call to heel- forward - Handler halts and dog sits, while the dog remains sitting the handler takes 2 steps forward and pauses, the handler then moves forward and calls the dog to heel as they move forward.

Excellent signs have been renumbered 201- 299. Although it stops at 211 and then they have 2 signs numbered 298 and 299. This is to make room for adding new signs to all the rally classes in the future. All the old signs in each of the levels continue to be the same. The excellent class has 8 new signs added to it and the Honor sign is being removed.

206- Down while heeling- without pause or hesitation handler will command dog to down and stay as the handler continues to move forward 6 feet to the new sign -299- Call to heel marker- Handler will turn and face the dog, this is a change of direction, and call the dog to the heel position. The handler must pause before moving forward. 207- Stand while heeling - While moving, without pausing the handler will tell the dog to stand and stay and continue moving 6 feet to the call to heel #299 sign without pause. The handler will then face the dog and call it to heel position. This is a change of direction. Dog must return to heel position and sit; handler must pause before moving forward. 208- Stand-leave dog- sit dog- call front-finish- While heeling the handler will stop and command dog to stand, dog must stand and not sit first, tell dog to stay and move forward 6 feet to the sign # 299 marker-Call to heel.

Handler will turn and face dog, then the handler will command/signal the dog to sit, after dog sits the handler will then call/signal dog to front and then finish or call to heel. This is a change in direction exercise. Handler must pause before moving forward. 209- Stand- leave dog- down dog- call front- finish- while heeling the handler stops and stands dog. Dog must not sit first, then move forward 6 feet to the #299 sign- call to heel, turn and face dog. Handler will then command/signal dog to down. When dog downs, handler will then command to come to the front and sit, and then to the heel position- dog must sit in front and at heel. This is a change of direction for the team. Handler must pause before moving forward. 210 - Send to jump- At the sign for this station which will be approx 10 feet away, the handler will command/signal the dog to jump. Dog must leave handler and take the jump. Handler may move in a straight path of at least 3 feet distance away from the jump and may not pass the jump until the dog has returned to the heel position. The AKC states in the directions for this sign that the dog can back jump to get back in the heel position. However the dog must not stop at any time during the working of this exercise. Once the dog has resumed the heel position the team can continue on to the next station. 211 - Double left about turn- this is probably the only sign I like of the new signs, While moving with the dog in heel position the handler makes an about turn to the left while the dog goes around the handler to the right and into heel position again and then the handler takes one or 2 steps forward and repeats, making this a 360 degree turn and you should be going in the same direction you were heading when you first met up with this sign. The dog does not sit at any time during this exercise. This is similar to the Novice sign 29- Left about turn, but you now do it twice. 298- Sit/Stay- This sign will be used as a marker, the dog will sit on command and stay while the handler leaves the dog and walks to retrieve the leash, returns to heel position of the dog and then the judge will say exercise finished. Handler must hook up dog to leash.

The Excellent class also has changed in that instead of having a minimum requirement of only 2 signs in the class of the Excellent signs and 3 Advanced stations, it is now 3 Excellent signs that must be used and 2 Advanced signs. I am not thrilled with the new excellent signs except the double left about sign. Some of the exercises could hinder a dog that is working in the obedience ring because except for in utility where the handler must call the dog to heel after an exam, all dogs come to the front and sit on any form of recall. This could be confusing to the dog; especially those that are not up to utility level and for those that have not entered into obedience but are hoping to in the future. The send to jump could be a disaster for

those that are doing Open Obedience or Utility obedience because instead of being an introduction to jumping for starters, it is now contradicting what dogs must do in obedience. There has been talk that many exhibitors may take a mad rush to enter shows and earn those titles prior to the new rules on April 1 being enforced. From a Judges perspective, I have not con**tributed to the conversations going on in the judges' forum but many are saying they will not be** using some of the newer Rally signs on their courses except those that are required. Only time will tell if these new rules will have any impact on the Rally ring, the entries have been slowing down at shows since all the obedience people have earned their titles and moved back into obedience classes or other venues. New comers were enjoying Rally and the less stringent rules for a while, which is becoming stricter. I have made it a habit to go yearly to AKC seminars to keep updated of all the rules as they continue to change and the judging rules continue to evolve stricter. The requirement for judges is once every 3 years but the rally continues to change dramatically so it is important to go to these seminars whenever available to learn from them.

Since this was so long, I will not venture into the obedience report at this time. Here's hoping that your skills for Obedience and Rally and the fun that you have in this venue continues.

I always am asked how I got started in rescue and the truth is, I don't know! One day I wasn't involved and the next day I had these funny little white creatures running around my house. I didn't purposely set out to rescue Bichons or any breed. I wanted to help in some way but never thought it would go this far. I started by walking dogs at a shelter, then I became their intake person. Because I had white dogs, I became the white dog specialist. Oh what I didn't know back then!

I think back over the 20 years of being involved in rescue and there are some dogs that have stayed in my heart. My first puppymill bitches still have a piece of my heart even though they have both passed. I remember being called about these two girls and I said I would take them. My husband and I set off on a very hot Sunday to northwest Ohio to pick up these girls. OH MY LORD DID THEY STINK! Even though it was in the 90's, we had to put our windows down. You could see the fleas crawling on them. On top of that, one had a blue tongue and the other looked like it was going to die right there. I immediately named her Hope because I hoped she wouldn't die before we got back to Pittsburgh. We made it back and, as sick as these girls were, I dipped them in flea dip. I called the vet first thing Monday and was told to bring in the girls. Hope had bladder stones bigger than her bladder and she was going into sepsis. Dr. Oster did emergency surgery and told me she did not know if Hope would pull through. Hope survived. When I went to pick her up days later, the vet tech brought Hope out, carrying her very gingerly. She looked at me and said "I really love Hope". I told her that was nice. She looked at me and said "you don't understand. I REALLY LOVE HER!" Oh..ok. I told her to have her mother call me and we could talk about adopting Hope. Kelly gave me a very strange look and then said "I'm 35 years old and married with three kids." I took my size 10 out of my mouth and said 'ok'. Kelly and I have become friends and I've even talked about rescue at her children's schools.

I named the other girl Lily. She had a heart condition and went on medication. Lily was one of the great loves of my life. She was so sweet and shy. I remember our first day home and it started to rain. Lily went under a bush to stay dry. Remember the Grinch whose heart grew three sizes that day, that's what happened to me. I picked Lily up and realized that no one had ever loved her before. No one carried her or rubbed her tummy. No one kissed the top of her head. No one had ever held her close and said "I love you and you will always be safe." I think that was the moment that I became a real rescuer. I became very protective of Lily, none of the people I talked to or received applications from were good enough for her. I had her for awhile and thought about keeping her. Then one day I received a phone call and a voice said "Hello, my name is Carol and I am looking for a Bichon." Something went from my heart to my head and said "this is who you have been waiting for. This is Lily's mom." Carol came to meet Lily and we cried together. The day Lily passed, we cried together again. Carol and I have a bond because we knew Lily was a special little girl.

Why do I rescue? It is because of the Hopes and Lilys of this world. They don't have a voice to speak for them. Rescuers are their advocates. I am here to fight for these little ones. I am here to say "I love you and will protect you."

Qualifications for ROM/ROMX

It is the responsibility of the Owner of a proposed dog to submit the required information to the ROM/ROMX Chairman for confirmation. The Owner must be a BFCA member in good standing. To be eligible for a Register of Merit (ROM) Award, the subject dog is to have been: the Sire of seven (7) or more, or the Dam of five (5) or more, Champions of Record. To be eligible for a Register of Merit Excellent (ROMX) Award, the subject dog is to have been: the Sire of twenty-five (25) or more, or the Dam of ten (10) or more, Champions of Record. The progeny are to be Champions of Record, confirmed by AKC.

How to apply for your award:

To apply for your ROM/ROMX please submit the following two documents:

- An AKC Progeny Report for the sire or dam, listing the Champions of Record available from the AKC On-Line Store for \$25.00; OR publications from AKC Gazette, AKC Awards, BFCA Banquet Awards Booklets or Bichon Reporters verifying the Champions of Record.
- 2. Copy of current AKC registration, showing all owners of the sire or dam

<u>Note:</u> If you are unable or unsure about obtaining the AKC Progeny Report, then you may submit your request with a copy of the current AKC registration and a non-refundable check for \$25.00. I will obtain the AKC Progeny Report and mail a copy to you.
