## AKC DELEGATE

June 2017

Toby Frisch, BFCA Delegate

Thank you for inviting me to do this job for BFCA. The meeting started with sadness upon hearing that Steve Gladstone, AKC Board member and delegate, had passed away while judging in Australia.

I was able to attend two of the committee meetings on Monday - Parent Club and All Breed Club meetings. I attended the Parent Club meeting and there was much talk on the AKC Market Place. Some of the parent clubs are unhappy about the pictures that are allowed of their breed. Some of these pictures have disqualifying features. It was reported that the AKC Market Place site would have a link to the Parent Club and have it as the first reference when someone is searching the Market Place. Market place should have the Parent Club breed referral on the site. It is the Parent Club who can educate the public. The Parent Club should get the first place on the ad page and this would be free to the Parent Club.

At the All Breed Club meeting it was suggested the Treasurers be bonded and 59% of clubs conform. Another suggestion was to have an Audit committee and have the books done yearly. The clubs should buy laptop computers and pass them on to new treasurers. Another suggestion was when checks are for a large amount two signatures. Also make a list of what the club owns and where the items are kept. Make budget - one for the club and one for the specialty.

The next day there was a Forum with the topic "Dealing with Misconduct". There were 19,638 events held with 142 event hearings. Presentation was very well done and lots of situations were mentioned and how to deal with them. Knowing the procedures outlines in the Dealing with Misconduct is so important; and if these events are not held properly it can be lots of problems and in some cases fines for the clubs. This booklet is a must-have on show grounds for every show and extras to give out to people who are involved in the problem.

There was a vote on the proposed amendment to Chapter 16, Section 6 of the Rules Applying to Dog Shows, which would include the eligible Best of Breed and Best of Variety non-regular class entrants in the calculation of Grand Championship points. Currently dogs that win Best of Breed or Opposite Sex and Select from a non-regular class (such as Veterans) can earn Grand Championship points but are not included in the count for Grand Championship. This passed.

Other items having to do with Beagle Federations were talked about.

Some of the items were very interesting and other items were... until next time.

## AKC DELEGATE

September 2017

This was the 16<sup>th</sup> anniversary of the attack of the World Trade Center, which was noted with a moment of silence at the meeting that day and at the regular Delegate Meeting on Tuesday. It was just after the horrible hurricanes.

I attended the Parent Club meeting and much was talked about the trailers for Texas and over \$70,000 in donations that were collected.

Marketplace had a rise of 21% for litter registration. The fee for placing an ad in Marketplace is \$29 per litter.

At the All Breeds committee a presentation was given for club finances. All breed clubs should have oversight of the treasurer that ensures transparency. A treasurer's report should be given in writing and backed up with bank statements. All club treasurers should be bonded and insured. Clubs should maintain liability insurance in the amount of \$2 million dollars.

The Parent Club was told that AKC Museum would archive records of their clubs.

At the Delegate Meeting on Tuesday new Delegates were introduced. A report on the finances of AKC was given. Total Revenue was \$3.8 million, which is a 10% increase. Registration is up 6% - \$1.2 million and Recording events fees \$227,000 up 3%. Interest and Dividends was at \$109.000 up 20%

There will be a new website for AKC (again) sometime this fall. AKC.org is the 2<sup>nd</sup> most ranked dog website with over 51 million visitors so far in 2017.

There was a vote on an amendment to Ch 16 section 6 that would include the dog awarded select Dog/Bitch in the calculation of the Grand Championship points for that award-PASSED

There is a famous line from Godfather III - *Michael Corleone: "Just when I thought I was out... they pull me back in*!" Well, I'm back! When Gail was elected BFCA President, she told me to get my butt back into rescue. Lucky me!!!

We had our Annual Bichon Bash in September. As always, it was a success. Didn't have as many participants but that is the way these things go. We made \$8,250 after expenses. Kudos go to Zandra Kern, new BFCA member Merry Nicole Meyer and the MD/VA volunteers. They do a terrific and a hard job each year that includes putting up a temporary fence so the dogs can be off lead. For the past five years or so, all we have been getting are older dogs. It seems they were always 10-12 years old. Thank the rescue angels that we were able to place them. Lately, we have been getting in younger dogs. We even took in a two year old, which caused us to break open a bottle of wine! Naturally, it hadn't had any vaccines and was intact. This seems to be the trend lately. Another problem we saw were juvenile cataracts. Our policy is, if the dog isn't in pain and can see otherwise, we don't do cataract surgery. What do we get? Young dogs that are blind due to cataracts. So, we do the surgery. Two dogs had to have an eye removed because of trauma or lack of care. Lots of dentals. That seems to be our big surgery this Summer. Only had two bladder stone surgeries. We placed 50 dogs so far this year. We have seven in foster care and one permanent resident.

Had to put one 9-year-old male down due to temperament. He bit twice and never signaled the bites. He would be happy and next minute, biting. Always makes us sad when we can't save one.

Vetting is getting more expensive. The day of \$85 spays are way behind us. Average office visit is \$50 and that just includes a physical. Anything extra is added, down to syringe disposal. We are lucky if the vet gives us a discount. We have been losing money on all the dogs. Thankful for the Bash and our followers for their donations. We also have been placing dogs with adopters doing the vetting themselves and we get a nominal placement fee. We are having a Pampered Chef fundraiser. We get money from Pampered Chef and Dawn Robertson, one of our volunteers, donates her income from the sales. If you have used Pampered Chef, here is a way to help rescue. If you have never used it, you don't know what you are missing. Fundraiser starts October 15 to November 5. https://www.pamperedchef.com/pws/dawnthecook/guest-landing/9097558768795
