Article I, Section 1, (a), (b),(c),(d) of the By-Laws:

Individual Membership: shall be comprised of individuals who are reputable citizens of the United States and who are eighteen (18) years of age or older.

\$40 (discount for cash or check) PP \$41.60

Household Membership: shall consist of two (2) adult members residing in the same household, who are reputable citizens of the United States, each are eligible to vote and hold office.

\$50 (discount for cash or check) PP \$52

Junior Membership: shall be comprised of reputable citizen of the United States who have attained the age of ten (10) years of age, and who have not reached the age of eighteen (18) years of age.

\$10 (discount for cash or check) PP \$10.40

Foreign Membership: shall be comprised of reputable citizens of a country other than the United States, who are eighteen (18) years of age or older, and who subscribe to the purposes of this Club.

\$40 (discount for cash or check) PP \$41.60

Article I, Section 3: DUES SHALL BE DUE AND PAYABLE ON OR BEFORE JULY 1ST OF EACH YEAR.
