Health Committee

Report to Board 2020

It is with the greatest delight that I can report to the board as well as the BFCA membership that their health committee is in force with six outstanding, intelligent, dedicated members, Mayno Blanding, Paula Hendricks, Vickie Halstead, Ginny Humphries, Laura Winston and Amy Walters. With the focus of improving the health of the Bichon Frise, each brings individual talents to give.

The initial concern of all health committee members was to encourage testing of all Bichons. As Mayno was writing articles for the AKC Gazette and sharing them in Health Times, Laura Winston was also writing a series of articles for The Bichon Frise Reporter. When the board decided to feature a Futurity in our specialties, the committee, unanimously, voiced hope that there would be some qualifying that included testing.

The OFA survey is still in the works. It has taken longer to get this survey as we wanted. In addition, the OFA's help is limited as it has time to assist. It is our intention to have that on the website by our September specialty.

As chairman, it was interesting as the committee chose the AKC/CHF research grant to support this year as each member brings insight into the value of those grants presented. The final conclusion was that any drug resistance to the heartworm would endanger, not only the Bichon, but all dogs. The agreement of the research grant to support is:

02458-AA Laboratory Test for Detecting Drug Resistance in Canine Heartworm Disease Principal Investigator: Matt Brewer, DVM, PhD; Iowa State University Total Grant Amount: \$15,000 Grant Period: 2/1/2018 - 1/31/2020 Project Abstract: Dirofilaria immitis is the nematode parasite that causes heartworm disease in the United States. Heartworm infection causes severe pathology and suffering in dogs and cats. Until recently, heartworm infection was a preventable disease due to the availability of effective monthly preventative

treatments. A recent development shows drug-resistant heartworms have emerged in the United States. The scope of the resistance issue has not yet been characterized because there is a critical need to develop a test that can discriminate drug-susceptible and drug-resistant parasites. Recent research assessed computer-aided motility studies of the parasite in the presence of drugs, however, there are no motility differences among parasite isolates in these assays. The investigators have developed biochemical stains and measurements that can quantify parasite killing in the presence of anti-parasitic drugs. In this study, the investigators will evaluate various metabolic assays and staining procedures to compare drug-susceptible and drug-resistant heartworm isolates in an effort to identify the best assay for detecting heartworm killing, and thereby creating a tool to rapidly identify resistant infections in dogs.

A close second was the research grant the BFCA supported last year: 02518 The Effects of Early Life Experience on Working Dog Temperament and Cognition

When our member, Pauline Schultz, died, there was a great outpouring of memorial funds. Deedy, her daughter, asked that because Pauline was particularly concerned about luxating patellas in the Bichon, to put the funds toward research in that area. There has been little direct research in particular in that area, but this year a grant was found that meets that criteria.

02682-AThe Effect of a Modified Approach on Early Weight Bearing in Dogs Following a Tibial Plateau Leveling Osteotomy Principal Investigator: Dominique Sawyere Hansford, BVSc, MS; Virginia-Maryland Regional College of Veterinary Medicine Total Grant Amount: \$14,939 Grant Period: 1/1/2020 – 5/31/2021 Project Abstract: A tibial plateau leveling osteotomy (TPLO) is a common procedure performed to address stifle (knee) instability secondary to cranial cruciate ligament rupture in dogs. During the surgical approach for a TPLO, some of the tendons of muscles attaching to the inside of the tibia are

cut. These tendons are referred to as the medial crural fascia. The medial crural fascia is important for the normal function of the dog's stifle. As opposed to the rapid gain in wound strength displayed in skin and the GI tract, restoration of fascia integrity is relatively prolonged. In the first week of healing, fascia incisions have no inherent strength; therefore, the repair is entirely dependent on the suture material, making it prone to inadequate healing. The clinical implication of this on early weight bearing and limb use following TPLO surgery is unknown. Additionally, tendons only reach 50-80% of their original strength at one year following reconstruction. In humans, deficiency in the repair of the medial crural fascia has been associated with decreased rotational stability, increased meniscal injury, and continued knee instability following surgery for cranial cruciate ligament rupture. If these findings are consistent in dogs, lack of attention to medial crural reconstruction and its inability to return to the original strength may contribute to continued subluxation of tibia and latent meniscal injury In this study, dogs who undergo a modified approach to a TPLO will be evaluated to determine normalization of gait parameters and thigh circumference as compared to dogs who undergo a standard approach to a TPLO. Results from this study may change the approach to TPLO surgery in the future and provide canine patients with improved short- and long-term outcomes.

The support of the board for the work of the health committee is very much appreciated.

The Importance of Canine Health Testing

We have seen or heard of terrible outcomes from inheritable diseases in our family dog or within our breeding program. Dogs have been affected for generations with crippling disorders and life-altering inheritable diseases. Many are preventable by health testing parents, the dam and sire of the puppies. Health testing makes it possible for a breeder to make informed decisions from health tests done on their breeding stock, thus allowing them to adapt or alter their breeding program, reducing the risk of puppies exhibiting the diseases in future generations.

Inherited diseases in purebred dogs can be better controlled by using careful, selective breeding pairs. This also creates an advantage for puppy buyers knowing they have a lower risk of their new dog inheriting breed-specific health problems because the dam and sire have favorable test results.

It is common for purebred dogs to be screened for inherited diseases starting with the dog's joints, heart, immune system, eyes, metabolism, renal and liver function, providing you, the breeder or puppy buyer, with valuable information.

More sophisticated and advanced health screening that includes DNA testing in purebred dogs, can use many different databases to analyze pedigrees and create matches based upon their males and females that show strengths rather than weaknesses. DNA tests can look for specific diseases in determining a canine's genotype, or phenotype evaluation. This type of information not only renders results about the dam and sire, but other close relatives including siblings (littermate), half-siblings, aunts and uncles, and grandparents. This is valuable information for a breeder to make greater selections in parings to produce superior offspring and to avoid inheritable diseases.

Health testing and DNA screening is not a perfect science, yet it is the only way to determine that a dog is free of an inheritable disease. Common sense leads us to believe if a dog is not health tested, one can assume there is a possibility of inheritable disease because it is not ruled out. Inheritable diseases are that common among all canines, and those known breed-specific disorders.

Orthopedic Foundation for Animals (OFA) https://www.ofa.org is a non-profit organization that has set the accepted standards and perimeters for canine health testing. OFA collects and openly shares test results in an effort to identify and therefore, decrease inheritable diseases in animals. The most common health testing is hip dysplasia, elbow dysplasia, patellar luxation, cardiac, thyroid, and eye disorders. Tests results, that meet their protocol, are submitted to OFA and based upon their authority for canine health testing, dogs are only considered free of these diseases when certified that the dog has met OFA standards.

OFA maintains databases on many genetic disorders. Furthermore, OFA has breed -specific protocols where the parent club participates in the Canine Health Information Center (CHIC) program. Having a CHIC certificate means the dog has completed all the health testing required for the breed, but does not guarantee results. It is simply the dog has met the parent club required testing and the owner has allowed the results to be in the public-accessible database.

Most reputable breeders avail themselves of heath testing and DNA results as tools to allow good breeding decisions that improve their assessment of genetic risks and inheritable disorders, including inbreeding coefficients and genetic markers. These breeders take the time and utilize resources, thus allowing them to be more open and honest about their breeding program. Cost is a real consideration, given a single high-quality canine DNA test can range from \$60 to \$170, depending on the accredited laboratory and the specific array of testing. DNA analysis can look at conditions caused by a simple mutation of only one gene. This result provides information about a disease or disorder in a predictable manner, reducing the risk of producing adversely affected puppies when the test results for both parents are known. Not always, but often a specific mutation is known to cause a single gene disorder that can occur in individual breeds, but can also occur in cross breeds and mixed breeds.

Well-versed breeders understand the fundamentals of health testing and DNA analysis in controlling genetic disorders. These tests are extremely valuable tools, but they are available for only a fraction of the known genetic disorders. Preventing inheritable conditions in dogs will not come from health and DNA testing without using all of a breeders tools including consideration of temperament, assessment of conformation to the breed standard and research of at least a three-generation pedigree. Having a solid, well thought-out breeding program allows a preservationist breeder to commonly test for issues in purebred lines promoting responsible breeding and more confidence in puppy buyers.

Qualifications for ROM /ROMX

It is the responsibility of the Owner of a proposed dog to submit the required information to the ROM/ROMX Chairperson for confirmation. The Owner must be a BFCA member in good standing.

To be eligible for a Register of Merit (ROM) title, the subject dog is to have been the sire of seven (7) or more Champions of Record or the dam of five (5) or more Champions of Record. To be eligible for a Register of Merit Excellent (ROMX) title, the subject dog is to have been the sire of twenty-five (25) or more Champions of Record or the dam of ten (10) or more Champions of Record.

To apply for your ROM/ROMX please submit the following documents:

- 1. An AKC Progeny Report for the sire or dam, listing the Champions of Record available from the AKC online store or a copy of the publications from the AKC Gazette, AKC Awards, BFCA Banquet Awards Booklets or Bichon Reporters verifying Champions of Record.
- 2. A copy of current AKC registration
