will judge Puppy and Junior Sweepstakes. The Bred-By-Exhibitor Special Attraction is another event for our dedicated breeders, and this year will be judged by Karen Graeber. Please be sure to watch and applaud our Parade of Champions & Titleholders between BBE dogs and BBE bitches.

Our Judges Seminar will be held immediately after the show on Thursday. Lorrie Carlton and Dir Spruiell will be doing the presentation and hands-on demonstration. Our National Specialty attendees are invited to attend the presentation (not the hands-on part); however, there is a limited number of spaces which will be handled on a first come first served basis. If interested in attending the presentation, please contact Mary Spruiell at <u>mspruiell@aol.com</u>. Dir Kovar is handling the sign-up process for Judges wishing to attend the program.

More information on BFCA's Judges Education program changes will be presented in an upcoming section below.

On to Friday! The morning starts with Junior Showmanship Competition. Young dog enthusiasts are the future of the sport of purebred dogs, so please encourage and support the Juniors. Next is the 4 to 6 Month Puppy competition. Both Junior Showmanship and 4 to 6 Month Puppies will be judged by James Fehring.

Last, but not least, Conformation! I am confident that everyone will support and give a very warm welcome to our conformation judge, Bill McFadden.

While at the week's activities, please remember to seek out new members, exhibitors, and spectators to say a warm hello and make them feel welcome.

Along with all the work surrounding our upcoming National Specialty in Tulsa, your Board continues to be busy working on your behalf. As I alluded to above, a Judges Education Program Review Committee, consisting of Dir Antetomaso (Chairperson), Dir Spruiell, and Carol Fellbaum, began their work by reviewing Ringside Mentoring, which is an important, integral part of Judges Education. Knowledgeable, experienced Ringside Mentors are an asset to BFCA's Judges Education program. The Committee presented its recommendations consisting of requirements to become a mentor and a mentor application form. The Committee recommends that the Board approved BFCA mentor list be utilized to select ringside mentors from the geographical area where the show will be held.

The Committee also recommends that, instead of a single Judges Education Chair, BFCA should have a Judges Education committee that would be led by a Judges Education Coordinator. Both the Judges Education committee and the Judges Education Coordinator are to be Board approved. As with all Standing Committees, this Judges Education committee and the Judges Education Coordinator should always be subject to the final authority of the Board. The Board approved all of the above Judges Education Program Review Committee's recommendations.

The Ringside Mentor application was distributed to the membership. I am extremely pleased with the number of members who completed the mentor application. BFCA is fortunate to have such qualified individuals participate in BFCA's Judges Education Ringside mentoring program. My sincere thanks to all of you!!! Cont.

The Board further approved Mary Spruiell to be interim Judges Education Coordinator. In the near future, the Board will send out a communication requesting volunteers for the Judges Education Committee.

The Board directed Dir Antetomaso to continue the next phase of her committee's review of BFCA's Judges Education Program. I will keep the membership apprised of Board approvals of further recommendations by this review committee.

The Board approved holding a Parent Club Specialty and Designated Specialties in conjunction with the Winter Wonderland Cluster All-Breed shows in Perry, GA. BFCA's Designated Specialty shows will be on Friday, Saturday, and Sunday, December 2-4, 2022. Our Parent Club Specialty will be held on Saturday, December 3, 2022. Foy Trent Dog Shows will be our Superintendent for our Parent Club show. BFCA will host a Welcome Reception which is tentatively planned for the evening of Thursday, December 1, 2022. Dir Spruiell will be the Show Chair. More information will be provided as the show dates approach.

A Performance Awards Review Committee was tasked with reviewing all Performance Awards and to recommend to the Board any changes to our current BFCA Performance awards (additions, deletions, types of awards, etc). Linda Ferrullo is the Committee Chair along with Dir Spruiell as the Obedience/Rally representative as well as Board Liaison for this committee, and Sari Bankson as the Agility representative. The Board will review this Committee's recommendations in the coming months. Thanks to Ms. Ferrullo, Dir Spruiell, and Ms. Bankson for agreeing to be a part of this important committee!

As directed by AKC, BFCA submitted another Letter of Intent to revise our Constitution and ByLaws. As you all know, BFCA needs to revise our Constitution and ByLaws to allow for all things electronic. This revision topic will be the Board's priority. After the membership approves the revision for allowing BFCA to conduct any and all of its business electronically, the remaining sections of BFCA's Constitution and ByLaws will be reviewed one topic at a time for any revisions. The Board will send a communication for member volunteers who wish to be part of a committee to review a particular section/topic. Once a particular topic/section is revised and approved by the membership, the Board will send out another volunteer request for another particular topic/section for revision and membership approval. This process will continue until the entire Constitution and ByLaws have been reviewed/revised/approved by the membership. Only after AKC approves all revisions can BFCA begin operating under a revised Constitution and ByLaws.

Regrettably, Amy Walters had to resign from the Health Committee. Thank you, Amy, for all your work on this important BFCA committee!

The Board welcomes the Health Committee's two newest members, Amanda Aaron and Donna DeMartini. We know these two ladies will be an asset to the Health Committee.

# **Delegate's Report**

Report to the Board 2022 Mayno Blanding

March 7 and 8, 2022. Reports on Health Committee, Parent Club Committee, and the Delegate Meeting.

### HEALTH COMMITTEE highlights:

**AKC Canine Health Foundation:** The new CEO of the AKC/CHF, **Dr. Darin Collins**, reported on research activities of the Foundation during the first quarter of 2022. *Eight current research projects are seeking to enroll canine participants. Owners can find the list of these projects at:* 

<u>http://www.akcchf.org/participate</u> There are several that are for all breeds and one, *Medical Resolution of Gallbladder Mucocele Formation in Dogs*, that lists Bichons as a breed of interest. Our Health Committee is looking at these grants for possibly donating BFCA funds. *Take a look and see if you might want to get involved*.

**OFA (Eddie Dziuk):** *OFA encouraged us to put photos of our dogs on the OFA website*. Newly issued CHIC numbers get transferred to AKC every month.

**Veterinary Outreach (Keith Frazier):** AKC has been doing many seminars and they have been wellreceived and well-attended. If you live in a state with a vet school, maintain a relationship with them. They NEED to know about our high standards and what we are about. AKC will help local clubs put on presentations. They have many ideas and lots of experience. For more information, you may contact Mari-Beth at: <u>mbo@akc.org</u> Vet students who attend these events gain a new appreciation for purebred dogs and their breeders. Many are unused to seeing so many healthy dogs, representing breeds that they usually encounter because of illness, actively participating in a wide variety of activities.

**AKC Purebred Semen Bank (Dr. Charles Garvin):** Outside legal consultants are currently preparing the 501c(3) application for the IRS. This is slowing things down but necessary. Currently, parent clubs (PCs) are encouraged to work on the following (which our BFCA Health Committee is doing):

- a) Designate a point person or committee chair as responsible for communication concerning the semen bank with the AKC,
- b) Develop the criteria for selection of semen donors,
- c) Decide what data, including photographs, regarding the sire are to be submitted with the semen,
- d) Develop criteria for accessing the banked semen, both for the bitch who will receive it and the breeder requesting it,
- e) Develop a mechanism for dispute resolution.

*FAQ is now on the Delegate's Portal for download and sharing with club members.* **Dr. Jerry Bell** is working on a white paper to explain the value of creating this forthcoming entity.

Low Entry Conformation Breeds (Dr Carmen Battaglia): Almost every breed new to the AKC in the last 10 years is "going south". He wants to know why this is and is doing research.

**Health Clinics at Shows (Dr. Christensen):** Apparently, there are fewer health clinics being held since Covid and people are having a hard time finding them. There is a link to upcoming health clinics at the top of the OFA home page but the *clubs need to report them in order to be included*.

#### PARENT CLUB (PC) COMMITTEE: In addition to many of the issues discussed at the Health Committee Meeting, the following items of interest to BFCA were discussed.

**Legislative (Sheila Goffe, Vice President Government Relations):** Some of you may have heard about Norway's animal welfare act which bans the breeding of Bulldogs and Cavaliers in that country. People can buy puppies of these breeds and import them but they cannot breed them. Section 25 of the act establishes breeding requirements to encourage good health of dogs and prohibit breeding that changes or passes on any physical or mental function in a detrimental way. It also deals with the ability to whelp naturally. In the US we are in the animal rights crosshairs now and it will impact us in the next few years. It starts in states – not at the federal level – and we can count on its happening. Sheila closed by reminding all of us of our responsibility to educate the public about the need to maintain breed conformation through standards developed by our PCs. In Norway, no one stood up to explain the purpose of purebred dogs and the importance we put on creating strong, healthy dogs through adherence to our standards. We must create a demand for healthy dogs.

**PC Best Practices Sub-Committee (Don James):** Most clubs don't do anything to bring in new members. The Membership Growth committee will try to change that and has added a new topic – *Breeder Education and Mentoring*. There are now 11 areas of concentration, and well-publicized webinars will be starting soon. They will be on Zoom and will highlight 5 subtopics. Following completion of the webinars, the entire outline of each topic will be posted on the AKC website and delegates will be able to find them on the Delegate Portal. *Anyone interested may ask me to find this for them when it is posted*.

**PC Breeder Development Sub-Committee:** They have submitted an award to the AKC board, called the **Eddy Award**, for clubs that go above and beyond to promote responsible breeding. *Mentoring guidelines should be coming out soon*.

**Breed Health Statement Update (Peter Piusz):** All PCs that have a currently approved health statement online have been notified. *PCs must be careful that the health statements in Marketplace and the statements on the breed page are in alignment*. AKC Marketing is working on combining the two databases that contain this info into one database so the statements will always be in sync. These statements will be read by non-club breeders as well as new puppy owners, so they need to be as clear and accurate as possible.

**Juniors (Mari-Beth O'Neill-AKC Staff):** Mari-Beth asked that all clubs appoint a Junior Coordinator. Staff will be proposing a change at the next Board meeting which will allow a Junior to handle a dog not directly owned by them or their family for all events.

**Breeder's Development Committee (Helen Prince):** A Breeder Education Survey was sent to PCs in Feb. and re-sent in March. Pupdate updates were also highlighted. Breed flyer reminders were also sent out reminding clubs to either update their existing flyers or create one if none has previously been on file. The June 2023 Delegate Forum presentation will center on breeder education and breed preservation. Katie Campbell is working on a series interviewing breeders of the year and other club breeders who have made an impact on their club. *Each PC will have the opportunity to nominate up to 5 breeders for inclusion in this recognition.* Michael Knight-AKC Board reminded Delegates to be sure their Presidents, Secretaries and Delegates email list is up to date. *AKC is concerned that info is not reaching individual members. AKC must rely on individual club officers to disseminate info to individual club members. If you feel you are not receiving enough info, please contact me or a member of the board.* 

**Disciplinary Action (Don James):** Don related an idea used by the Leonberger Club of America (LCA) about how they handle disciplinary actions. The LCA uses a system called Member Practices Assurance Committee (MPAC) consisting of 3 members whose job it is to act as the first responders for disciplinary actions. This group together investigates the complaint and decides whether it is actionable and needs to be passed up to their Board of Directors.

**5-Year Plan for PCs (Peter Piusz & Mari-Beth O'Neill):** Peter and Meri-Beth introduced the idea of developing a *5-year strategic plan for PCs to be discussed further in June*. It would deal with areas like breeding, plans for recruiting new members and participation in various events they or the AKC would sponsor.

#### **DELEGATE MEETING, MARCH 8, 2022**

**Elections:** March is the annual meeting in which elections are held. The Class of 2026 was elected as presented by the Nominating Committee: **Christopher Sweetwood** – Trap Falls KC, **Harold "Red" Tatro, III** – Fort Worth KC, **Ann Wallin** – Atlanta KC. There were no other nominees and they were declared elected by **Dennis Sprung Chairman of the Board**.

**There were moving tributes to Ron Menaker by Dr. Thomas Davies and Dennis Sprung. AKC Meet the Breeds:** We were reminded that MTB was to begin in April in Tampa and that *all clubs must support it.* Please respond to the emails and postal correspondence requesting Tampa MTB registrations.

**Chairman's Report (Dennis Sprung):** reported that contrary to the common perception of a loss of clubs due to Covid, he was pleased to announce that, in summary, over the past five years there was a net gain of 197 clubs. The reasons for clubs disbanding are the following: 1 – Aging out, 2 – Lack of membership and/or new members, 3 – Loss of convenient suitable and available sites in the area, or general loss of interest by club members over time.

The Financial Report (CFO, Ted Phillips): AKC is doing very well.

**Vote:** The only vote was an amendment to *Section III, I of the Delegate Standing Rule on Committees* – *Herding, Earthdog and Coursing Events*, which would change the Committee's name and now include *Scent Work. Appoved.* 

**Upcoming Vote in June:** Amendment to Chapter 11, Section 6 of the Rules Applying to Dog Shows, etc. – reformats the section for easier comprehension. If anyone wants to see the entire text, please email me at <u>maynob@gmail.com</u>

**PAC Fundraiser (Gail LaBerge):** PAC raised over \$19,000 for the PAC last year. PAC helps elect officials who support AKC's position on canine issues in legislation.

**Public Relations (Brandi Hunter Munden):** She is new and full of energy. AKC is mentioned in the media 75 times a day - online, radio, TV, print and digital articles thanks to AKC PR Dept. AKC has become the authority on all things Dog. They are doing aggressive national and local PR campaign for our TV shows, especially the National Championship. They did an impressive PR campaign for the Meet the Breeds tour.

**AKC Broadcasting (Ron Furman, Director of Sales and Bill Ellis, Director of Broadcasting):** On Super Bowl Sunday, Christmas Day and New Year's weekend the AKC was seen by millions of people across those three holidays. They had shows on every one of those weekends, including Fly Ball, Fastest Dogs USA, Nat Champ promo, Agility, and Juniors. The AKC produces and controls 100% of the content when they produce these TV shows, including the majority of the commercial times, and they use that commercial time to make sure they include mission messaging. ESPN loves AKC! Their viewership is substantially higher, especially in women.

# Health Committee Report



## Judges Education Report Spring 2022

The Judge's Education Committee has been very busy in the last quarter. We felt BFCA needed to put more emphasis on ring side mentoring as so many judges come in contact with our breed in that manner. The board agreed to start a new mentoring program which involved developing guidelines for mentors and asking for members to sign up if they were interested in mentoring. We had 20 mentors volunteer from all over the country which is an excellent number! It was also suggested that we do laminated cards for the mentors to remind them of the key points to cover from the standard and a committee of 8 experienced breeder/exhibitors were involved in picking out those points in each section of the standard to be included on our mentoring points card. This was completed and all mentors who would like copy will receive theirs at national. There has been one mentoring zoom meeting in March which was well received and covered a discussion of part of the standard and methods of mentoring. Newer mentors are being asked to attend the judge's seminar at National. Another zoom meeting covering other areas of the standard will be held in late summer.

The committee also decided to update the judge's seminar PowerPoint presentation which has been completed. The judge's seminar will be open to judges, current mentors, those who wish to be mentors in the future, BFCA general membership and nonmembers who are interested in learning the Bichon standard. The response to this has been very good and we expect a good turn out for the seminar.



Qualifications for ROM /ROMX

It is the responsibility of the Owner of a proposed dog to submit the required information to the ROM/ROMX Chairperson for confirmation. The Owner must be a BFCA member in good standing.

To be eligible for a Register of Merit (ROM) title, the subject dog is to have been the sire of seven (7) or more Champions of Record or the dam of five (5) or more Champions of Record. To be eligible for a Register of Merit Excellent (ROMX) title, the subject dog is to have been the sire of twenty-five (25) or more Champions of Record or the dam of ten (10) or more Champions of Record.

To apply for your ROM/ROMX please submit the following documents:

- An AKC Progeny Report for the sire or dam, listing the Champions of Record available from the AKC online store or a copy of the publications from the AKC Gazette, AKC Awards, BFCA Banquet Awards Booklets or Bichon Reporters verifying Champions of Record.
- 2. A copy of current AKC registration


# The New Jersey Bichon Frise Club
